适用范围

Applicability

本附录是对<u>特瑞堡集团的网站、电子邮箱及联系方式隐私政策</u>的补充,适用于在中华人民共和国(以下称"**中国**")境内进行的个人信息处理活动。鉴于本附录仅为补充性质,因此仅涵盖特别适用于中国的条款,并不涉及中国法中与隐私政策所适用的法律一致或更为宽松的内容。本附录中使用但未定义的任何大写术语均与我们的隐私政策中给出的含义一致。若本附录与隐私政策之间存在任何冲突,应以确保符合所适用法律的方式解释这些文件,并以本附录的条款为准。

This Addendum is supplemental to the Website, e-mail and contacts Privacy Notice – Trelleborg. It applies to the processing of Personal Data within People's Republic of China ("China"). As this Addendum is only a supplement, it covers only those provisions specific to China and it does not address those aspects of Chinese Law that is consistent with or less stringent than the laws addressed in the Privacy Notice. To the extent of any conflict between this Addendum and the Privacy Notice, the documents will be interpreted in the manner that ensure compliance with applicable law, and the terms of this Addendum shall prevail.
